on how to advocate for a loved one with mental illness in a county jail. An additional presentation was given to an audience of nearly 100 community and family advocates, by our Peer Policy Fellow at the annual African American Mental Health conference in Austin on the importance of peer support and family in recovery and reentry of individuals with substance use and mental health issues mired in the justice system. TJP also tabled, conducted outreach and made a policy presentation at a Reproductive Justice Conference organized by the Texas Women's University in Denton. More than 100 students were engaged and informed about the plight of women and especially pregnant women in over 240 county jails across 254 counties. We created 8 fact sheets to support 6 bills in the 2018 Texas legislature. We informed legislative staff on 7 bills and testified on 3 bills in the county affairs, criminal justice and veterans??? affairs committees. TJP provided direct assistance to 6 families that were affected both by Hurricane Harvey and the effects of pretrial detention in county jails. TJP's website was accessed by nearly 38,000 unique visitors comprising individuals and families in crisis, journalists, researchers and educators who used the information and resources we provided in over 47,000 sessions. TJP was interviewed by 7 state and 2 national media outlets on investigative stories on jails.
